



RISK FREE PROGRAM AUTHORIZATION TO SHIP FORM

In consideration of the mutual promises and covenants contained herein and intending to be legally bound, Buyer and Seller agree to the following:

- Buyer and Seller agree that all Risk Free products shall be sold on a sale or return basis, and that ownership of all Risk Free products will remain with Elite Sportswear, LP until payment is received or until inventory is returned.
- Buyer will have 60 days to either pay for the Risk-Free merchandise or return any unsold merchandise to the Seller. Items returned before the 61st day will not be charged. At the 61st day, Risk-Free inventory must be received back to Seller or payment will become due for merchandise that is not returned. In such case, the credit card on file will be automatically charged.
- Buyer is responsible for all return shipping and handling charges of \$20.00 per box and Buyer agrees that this charge will be automatically charged to the Buyer's credit card on file. Seller will provide the Buyer with a return shipping label which will be required for all returns.
- Buyer understands they will not receive credit for any merchandise that is not returned in the same condition as received. Merchandise is to be returned on original hangers and with all original tags attached. Worn, laundered, soiled, or damaged merchandise will be returned to the Buyer and Buyer will be responsible for the \$20.00, per box, shipping and handling charges of the return which will be automatically charged to the credit card on file.
- Buyer and Seller agree that the Seller will have 50 days from merchandise shipment date to notify Seller if Buyer would like to keep the entire box of merchandise or return it. If the Buyer decides to keep all merchandise, Seller will provide a 25% discount on the total Risk-Free package invoice if Buyer notifies the Seller prior to the 50th day of the invoice due date.
- Buyer agrees that all shipments of the Risk-Free program are Freight on Board (FOB) - Reading, Pennsylvania. Buyer is fully responsible for the Risk-Free merchandise loss in the event of theft, fire, flood, or any other natural cause.
- Buyer understands that any lapse in communication regarding Buyer's intentions of Risk Free merchandise, invoice payment or intent to return merchandise after the 65th day of Risk Free shipment will result in the credit card on file being automatically charged at the full invoice amount. No returns will be accepted after the credit card has been charged.
- Buyer and Seller agree that either party may terminate participation in the Risk-Free Program by notifying the party, in writing, at any time. Buyer agrees that accounts cannot be closed until all merchandise is returned or paid for.

By signing below, I agree to the terms and conditions outlined in this agreement, including but not limited to, all credit card charges for any invoice (net of credits) for merchandise returned that has not been paid by other means within the due date.
